





1ST HALF OF 2020

The negotiations on the future Erasmus+ programme will close under the Croatian EU Presidency. Negotiations on the successor programme of Europe 2020, including Education and Training 2020, will take place.

As the ET2020 framework is about to come to an end adult education stakeholders should see an opportunity to ask that following initiatives and frameworks:

PROMOTE LIFE SKILLS FOR A BETTER EUROPEAN FUTURE

MAKE LIFELONG LEARNING A HUMAN RIGHT

It is **crucial** that we push to bring adult learning to the front of the European agenda and now is the perfect time to do this. Adult education civil society can make the next framework truly relevant to ALE provision



What should the new Agenda contain?

EAEA recommended themes:

- Life skills
- Digitalisation and new technologies
- Democracy and European Values
- Health and well-being
- Older learners
- Media literacy
- Social inclusion of disadvantaged groups
- Sustainability

It is essential that there is a comprehensive European adult learning strategy after 2020. In order to help adult education to develop and use its full potential, EAEA proposes a close cooperation between all European strategies that concern adult education.

These include the New Skills Agenda, and especially Upskilling Pathways, the European Agenda for Adult Learning, the European Pillar of Social Rights, and particularly its first principle on the right to lifelong learning, the European Education Area, validation and recognition etc. They need to link closely to the existing European structures (EC Working Group, National Coordinators, EPALE, ...) as well as to global frameworks, such as the Sustainable Development Goals, and particularly SDG 4 on education

EUROPEAN AGENDA FOR ADULT LEARNING

EAEA recommended objectives:

- 1. Increasing participation of adults in learning
- 2. Promoting all forms of adult education and learning: general and vocational but also non-formal, non-formal and informal
- 3. Supporting adult education structures, including civil society that organises and provides adult learning
- 4. Reinforcing cooperation and partnerships among various stakeholders at the national and regional
- levels, including, for instance, social partners and academia
- 5. Extending the knowledge-base, especially of the impact of adult education
- 6. Improving the funding of adult learning
- 7. Improving the governance of adult learning
