





2 Influencing public policy

EAEA policy work at a glance



The EAEA has achieved several milestones in 2022. EAEA's overarching aim is to improve adult learning and education (ALE) both in policy and practice. The key guiding document for EAEA is its Manifesto for Adult Learning in the 21st Century. EAEA's strong focus on policy advocacy, capacity building, and stakeholder engagement contributed to a strengthening of the member network and the European ALE community in 2022.

Spotlight on Transformative Learning and Values

The EAEA Annual Conference on Transformative Learning and Values, held on 31 May in Mechelen, Belgium, focused on how adult learning can promote values to drive change in the face of global crises. The conference brought together EAEA members and partners to discuss the role of adult learning in transforming individual lives and societies, with a focus on green and digital transitions.

The conference was instrumental in shaping EAEA's content work on transformative learning and values in 2022, including developing a background paper that delved into transformative learning as a concept, pedagogical and policy perspectives, and the role of values. The paper concluded with case studies and recommendations on how adult learning can promote and foster transformative learning and values.

According to a member survey conducted by EAEA in early 2023, the annual theme was one of the most important topics for 56% of respondents. 82% of respondents also found the theme to be “very relevant” or “relevant”. Members who attended the conference provided positive feedback, noting that the event was helpful for the development of their adult learning programmes and advocacy work. All attendees confirmed that they gained new insights and inspiration from the conference.

Making a change for the European adult learning and education community

In 2022, EAEA achieved significant policy highlights, including its engagement with the European Commission's DG EMPL and DG EAC. This collaboration had an impact on the Erasmus+ mobility for adult learners, it has allowed EAEA to offer feedback on the take-up of new action from the perspective of adult learning providers. EAEA also aimed to increase the uptake of this action by engaging a broad European audience in adult learning education.

EAEA's Interest Group on Lifelong Learning at the European Parliament, which was coordinated by EAEA and the Lifelong Learning Platform (LLL),

met twice in 2022. The first meeting in May 2022 focused on values education and lifelong learning, and the second in November 2022 on investment in education and training for learning mobility. In the first meeting, EAEA was honoured to have the President of the European Parliament and member of the Interest Group, Roberta Metsola, participate.

EAEA addressed the digital and green transition through two member-led working groups. The engagement of EAEA's members led, among others, to the successful submission of a paper to a call of ESREA (European Society for Research on the Education of Adults) and the organisation of a side event - "No Greening without ALE!" - at the Stockholm+50 conference of the United Nations Environment Programme.

At the international level, EAEA was actively engaged in the preparation, participation and follow-up of UNESCO's CONFINTEA VII. Thanks to the

very active participation of EAEA's members, EAEA was able to submit proposals for amendments to the original proposal, which were included in the Marrakech Framework for Action that was adopted by the UNESCO Member States for the next 12 years. EAEA followed up on the conference with several webinars, news articles, and meetings.

Meeting and exchanging information with policy-makers at all levels

EAEA actively participated in two working groups of the European Commission in 2022: the Working Group on Adult Learning - Opening up Opportunities for All, and the Working Group on Equity and Values in Education and Training. Through these groups, EAEA shared its positions

and experience with its European membership, while also strengthening cooperation with ministries for education and employment at the national level.

In addition to these working groups, EAEA had regular online and face-to-face meetings with European policymakers, other platforms, and a wider stakeholder network in 2022. These meetings covered a range of topics, including discussions on the financing of adult learning in Europe and the implementation of the New European Agenda for Adult Learning.

EAEA's strong engagement of its members in policy and advocacy at the local, regional, and national levels allowed it to reach national and regional policymakers. Furthermore, EAEA's Board meetings in 2022 provided another opportunity to connect with policymakers and discuss important issues related to adult learning.

Strengthening networks through capacity-building

In 2022, EAEA focused on enhancing the quality and accessibility of adult education and training in Europe through various capacity-building activities. One of these was the Younger Staff Training, which provided a valuable learning experience for young professionals working in adult learning and education. This training program helped to strengthen their network and improve their skills.

Additionally, EAEA contributed to the professional development of executive staff in adult learning and education through the Advocacy Academy. This program was coordinated by EAEA's member DVV International and co-organized with EAEA and ICAE in December 2022.

Engaging stakeholders for cross-sectoral cooperation

EAEA actively engaged with various stakeholders in the field of adult learning and education throughout the year. This included a partnership agreement with ESREA, a research network for adult learning, and strengthened regional collaboration and partnerships among EAEA's non-EU members. Additionally, EAEA strengthened its collaboration with the

OECD to promote a wider understanding of skills and key competencies, resulting in a joint webinar and continued information sharing. Through stakeholder engagement and capacity-building activities, EAEA aims to have a positive impact on the development of ALE strategies in its member countries.

Increasing EAEA's visibility

EAEA significantly increased its visibility and impact in 2022 through various initiatives. EAEA participated in UNESCO's CONFINTEA VII and contributed to the Dublin Declaration on Global Education to 2050 and the Transforming Education Summit of UNESCO.

EAEA published 16 statements, info notes, and background reports on important topics for adult learning in Europe, including the New European Agenda for Adult Learning (NEAAL) and Individual Learning Accounts. EAEA also delivered presentations at various conferences and seminars, including for the French Presidency, and was invited by private companies to participate in events.

Additionally, EAEA was involved as an expert in the development of national and regional adult learning strategies. EAEA's annual theme of transformative learning and values helped increase its visibility beyond the sector and bring together members, partners, and new stakeholders from civil society and academia.

EAEA's impact at the national and regional levels

EAEA's members were central to making an impact by leading EAEA's advocacy activities in their respective countries and regions. The members worked on mainstreaming EAEA's life skills approach in national adult learning programmes, developing advocacy strategies for ALE and reinforcing regional cooperation of ALE stakeholders.

These snapshots from European countries and regions showcase EAEA's impact at the national and regional levels:



1. **Austria:** EAEA's Life Skills approach, developed in an Erasmus+ project between 2016 and 2018 and mainstreamed in EAEA's policy work since, inspired several key ALE stakeholders in Austria, including EPALE Austria, to promote this approach in Austria, resulting in several awareness-raising events.
2. **Belgium/Wallonia and Brussels Region:** Inspired by a good example of the Irish EAEA member AONTAS, the Belgian EAEA member Lire & Ecrire set up an info line for adults with difficulties in literacy and numeracy interested in learning opportunities.
3. **Belgium/Flanders:** EAEA was involved in an expert consultation process coordinated by the Department for Education and Training of the Flemish government, contributing to the development of the Flemish strategy for Lifelong Learning and linking it to European policy initiatives and strategies in ALE.

4. **Estonia:** Drawing on EAEA's recommendations on regional networks and partnerships in adult learning and education, the Estonian Folk High School Association, a member of EAEA, has been working towards reinforcing Baltic cooperation in ALE.
5. **Georgia:** EAEA's member, the Georgian Adult Education Network, worked on strengthening regional cooperation (South Caucasus) in 2022 by organising regional conferences and meetings, including developing peer learning training inspired by EAEA's policy and advocacy work.
6. **Germany:** EAEA member DVV, the German Adult Education Association, organised a national conference in June 2022, bringing together more than 900 participants, including high-ranking government officials and key experts. The theme of the event is - "Together in Diversity. Sustainable. Connected" – was inspired by EAEA's Manifesto for Adult Learning in the 21st Century.
7. **Hungary:** In a seminar co-organised by EAEA's member, the Faculty of Adult Education and Human Resources Development at the University of Pécs, the New European Agenda for Adult Learning was discussed by key Hungarian stakeholders, informing a debate on the implementation at the national level.
8. **Netherlands:** EAEA's Manifesto for Adult Learning in the 21st Century, published in 2019, and the Life Skills approach, were the basis for building a new Dutch platform for ALE. Led by EAEA's member Learn for Life, the new national platform for ALE brings together key stakeholders in ALE, aiming to reinforce ALE policy strategies and initiatives.
9. **Norway:** Inspired by the cooperation with EAEA in the ongoing RegALE project (Erasmus+ KA3), EAEA's member, the Norwegian Association for Adults Learning, decided to create a department on European cooperation within their organisation. This department will work closely together with the EAEA secretariat to exchange EU and EEA cooperation on policy development and implementation in the field of ALE.

- 10. Portugal:** Building on the adult education strategy that EAEA developed with Portuguese partners and DG REFORM a few years ago, Portugal has been working on the implementation of this strategy, including the development of a legal framework. To this end, EAEA's member APCEP organised conferences and seminars attended by stakeholders and policymakers.
- 11. Slovakia:** Slovakia was very engaged in building local partnerships between adult learning stakeholders, building on EAEA's recommendations from statements and projects. This contributed to a stronger engagement of local adult learning stakeholders with national and European policy-making in ALE.
- 12. Sweden:** Inspired by EAEA's Manifesto for Adult Learning in the 21st Century, EAEA's members in Sweden organised several meetings and events around sustainability and future-oriented ALE, including in the context of UNEP's Stockholm+50 conference on the UN environmental strategies.
- 13. UK/Wales:** In 2022, EAEA was invited by the Welsh government in a co-creation process for the Taith programme, which replaces Erasmus+ in Wales. EAEA's experience and recommendations on Erasmus+ have been considered throughout the whole development and piloting process, ensuring that adult learners are given a strong voice and are given access to mobility programmes in Wales.
- 14. Ukraine:** EAEA's member in Ukraine, the Ukrainian Adult Education Association, was very active in promoting peace, rebuilding and citizenship education. UAEEA also engaged in the development process of the new adult education law in Ukraine.

Cooperating across sectors and areas of work

EAEA's various European civil society partners provided a multiplier effect within their networks. These include the Lifelong Learning Platform, Social Platform, SOLIDAR, EUCEN, EUREA, ESNB and CONCORD. EAEA's Head of Policy Raffaella Kihrer was elected Vice-President of the LLLP in June 2022 to represent adult learning and education. A multiplier effect at the global level was ensured through ongoing collaboration with EAEA's global body ICAE, EAEA's sister organisations AAACE (Northern America) and ASPBAE (Asian Pacific Area), and a partnership with the UNESCO Institute for Lifelong Learning.



General Assembly 2022

The General Assembly of EAEA members, the main decision-making body of EAEA, met on 30 May in Mechelen to discuss and approve the EAEA financial and activity reports for 2021 and the plans for the upcoming year. The meeting was attended by 80 participants.

Grundtvig Award 2022

The 2022 EAEA Grundtvig Award sought innovative projects that advance transformative learning and values. The award winners were selected in two categories: national initiatives and transnational initiatives.

WINNER IN THE NATIONAL CATEGORY

Aging Laboratory

The national category winner was the Aging Laboratory, run by Câmara Municipal Ílhavo in Portugal, which cooperates with more than 15 academic partners and associations to increase knowledge on ageing. The laboratory has two dimensions: the creation axis develops creative projects and fosters intergenerational learning between seniors and artists, and the research axis hosts several research projects providing support to the projects and promoting interest in studying ageing.

WINNER IN THE TRANSNATIONAL CATEGORY

Brave New Words

The transnational project category was won by Brave New Words, run by CEIPES in Italy, which developed inclusive learning approaches using 3D printing and augmented reality, specifically designed for students with Special Learning Disorders (SpLD). According to CEIPES, the use of this special technology transforms the way people with SpLD learn by offering them a multi-sensory learning experience.

Annual conference on Transformative Learning and Values

The EAEA held its annual conference on 31 May in Mechelen, Belgium, which was attended by 75 people from 25 European countries. The main focus of the conference was to explore EAEA's annual theme in 2022, Transformative Learning and Values, and its link to challenges faced by European societies such as green and digital transitions. The outcomes of the conference were used to develop an EAEA background paper, featuring case studies and recommendations, and also contributed to the content work on transformative learning and values. Participants had a full-day programme which included five group discussions on the values adult learning and education should promote. They looked into values important for transformative learning, such as those of learners, educators, providers,

policy-makers, and broader European values. The conference also had a panel discussion on transformative learning and three parallel workshops on green transition, digital transition, and democratic processes.



EAEA Younger Staff Training

EAEA Younger Staff Training was held in Brussels from 12 to 16 September. Before the training week, two input sessions were delivered online. The training focused on guidance for learning and career and included participants from diverse backgrounds, which led to interesting exchanges of experiences and perspectives on adult education and guidance systems. The training covered topics such as policy and advocacy for stronger adult learning and guidance strategies, which were explored through peer-learning sessions, practical workshops, and study visits to two organisations in Brussels that provide guidance services: Leerwinkel and Cité des métiers.

Advocacy Academy in Istanbul, Turkey

The Advocacy Academy (12-16 December) was co-organised by DVV International, the International Council for Adult Education, and EAEA to assist adult learning organisations from six countries in creating their advocacy plans. During the training, which was led by EAEA's Raffaella Kihrer and Aleksandra Kozyra, as well as ICAE's Secretary-General Katarina Popovic, 27 participants from Armenia, Bosnia and Herzegovina, Georgia, Kosovo, Moldova, and Ukraine shared their advocacy challenges and opportunities. They also identified key issues that will be included in their advocacy plans.

Europe is more than the EU, Chisinau, Moldova

The International Conference on the Role of Adult Learning and Education in the Development of Local Communities was held on 9-10 November in Chisinau, Moldova. Participants from Armenia, Bosnia and Herzegovina, Belarus, Georgia, Moldova, Turkey and Ukraine attended the event, which was co-organised by DVV International and EAEA.

The main focus of the conference was on the issues related to local development in adult learning and education. Key challenges such as governance, financing and increasing participation of vulnerable learners were discussed, and the benefits of collaborations between adult learning providers and local authorities were highlighted.

Additionally, during a side member discussion, EAEA members discussed issues of common interest, such as quality in adult learning and education and network-building. The event was organised as part of EAEA's working group Europe is more than the EU.



EAEA information services at a glance



Communication channels

The European Association for the Education of Adults (EAEA) is the leading civil society voice for adult learning and education across Europe. EAEA's website and social media channels serve as key sources of information for the latest policy developments in the sector, reaching an ever-expanding community of adult learning and education professionals. EAEA uses a variety of communication channels to disseminate information, including infographics, news articles, statements, strategy papers, reports, and other publications. Starting in 2022, EAEA also increased its engagement with stakeholders through online discussions.

EAEA's social media channels aim to engage audiences with high-quality content and visually appealing designs. In 2022, EAEA's engagement rates on Facebook, Twitter, and LinkedIn remained significantly higher than the industry average. EAEA's LinkedIn channel saw the most substantial growth, with its followers increasing by over 200% from the previous year.

EAEA's Facebook page had over 8,500 followers by the end of 2022, and the page reached more than 51,000 users in the same year. The organisation's Twitter account had over 5,600 followers at the end of 2022. It achieved high engagement rates that increased quarter by quarter. The engagement rate on Twitter rose from 2.8% at the beginning of 2022 to 4.7% by the end of the year. EAEA's LinkedIn channel had over 2,100 followers at the end of 2022, up from 700 in 2021.

EAEA also disseminates information to its members through various channels. The "News from Brussels" email service is exclusively for members and provides regular updates on key policy developments. EAEA's statements are highly valued by its members, who have used them to contact their governments and build collaborations. EAEA's member newsletter, which is published 11 times per year, is another critical information source for members. EAEA's general newsletter, published six times yearly, reaches a broad audience, including policymakers, international organisations, authorities, ALE organisations, educators, and citizens. EAEA is also involved in regular exchanges with stakeholders on different topics, including preparing its contribution to CONFINTEA VII, through various thematic policy mailing lists.



EAEA continued to be an active member of the advisory board of the Electronic Platform for Adult Learning in Europe (EPALE) in 2022, providing editorial work and contributing to policy developments. EAEA also remains on the Editorial Board of [Elm Magazine](#) and is involved in the editorial work and continued collaboration under the "Speakers' Corner" column series. These collaborations have helped EAEA to expand its reach and impact.

The Finnish Ministry of Education and Culture continued to support EAEA's Communication Officer (through the Finnish Lifelong Learning Foundation – Kvs) in 2022.

Satisfaction with EAEA's communication work

EAEA members remained very satisfied with EAEA communication in 2022: 93% of the members who replied to the EAEA survey in early 2023 felt "very satisfied" or "satisfied". Members were particularly appreciative of

EAEA's policy news, articles about current topics and news about events. Members' most followed communications channels remained the EAEA Newsletter, Member Newsletter and emails.

EAEA 's project work in 2022 at a glance:



EAEA's projects focus on advocacy, policy and exchange of practices in adult education and lifelong learning. EAEA participates mainly in Erasmus+ projects but also other funding programmes (i.e. DEAR, Horizon Europe). With EAEA steadily broadening its engagement in project work, current projects are not only aiming at a concrete, practical level but also on a more tactical, political level.

The projects are covering a wide range of topics, such as digitalisation (e.g., DisinfoEND) and gamification (e.g., SAFE & SAA). In 2022, EAEA also got involved in additional projects targeting older learners (e.g., GreenerAGE, COPE & SAA).

Included target groups are low-skilled adults (MASTER), older learners, Migrants (e.g., Diversity) as well as volunteers and staff members/professionals (e.g., SRSS Spain, SUPPORT, ALL IN). However, some of the projects are also aiming at an organisational level (e.g., FOCAL & SMALEi) or even a more strategic development (e.g., CYLL).



EAEA's membership in 2022 at a glance



In 2022, EAEA enjoyed a close partnership with its members. Members were invited to join online discussions, to contribute to consultations and to EAEA working groups. Two working groups in particular were centred around members' contributions: the Working Group on Digitalisation and the Working Group on Quality in ALE. In addition, EAEA continued the activities of the Working Group Europe is more than the EU; the conference organised in Chisinau, Moldova in November included a side meeting of EAEA members, who exchanged around shared topics of interest.

Member satisfaction

Member satisfaction remained high. According to a membership survey carried out in early 2023, 97% were very satisfied with the work of EAEA. Similarly, 97% of respondents considered EAEA's impact on the policies at the European level to be either strong or very strong. Members were particularly satisfied with the provision of up-to-date information on EU policy developments about adult education, dissemination of project information and EAEA's advocacy on the European level for non-formal adult education and lifelong learning. Members also highlighted their appreciation of EAEA's thematic work on financing adult learning and education.


Finances


The Younger Staff Training brought some income as a small number of participants were able to participate in the face-to-face training in Brussels. EAEA also received some income from smaller service contracts.
