The Green Transition at the centre

Throughout the year, EAEA focused on adult learning and green transition, exploring both policy and practice.

The EAEA Annual Conference on Adult Learning and the Green Transition took place in Zagreb, Croatia on 7 June, and was hosted by Adult Education Institution Dante. The conference focused on two strands - Learning in communities and Strategies for a just green transition - and included a keynote speech from Arjen Wals, Professor of Transformative Learning for Socio-Ecological Sustainability at Wageningen University in the Netherlands, UNESCO Chair for Sustainable Development.

EAEA also encouraged an exchange of best practices by inviting ALE organisations to apply for the EAEA Grundtvig Award. From advancing sustainable agriculture in Armenia, to learning the “forgotten” circular skills across Europe, the winning initiatives displayed the transformative impact of adult learning on lives and communities.

To look at the grassroots perspective in adult learning and the green transition, in 2023 EAEA launched a podcast Beyond Learning, which explores stories of learning, and stories of change. EAEA met with learners and educators to discuss the role of museums in learning about sustainable development, bottom-up community building, co-creation of green public spaces, and more.

Concluding EAEA's thematic work on adult learning and green transition in 2023, the new background paper brings forward the perspectives of adult learners, educators, and community organisers in Europe. It is based on the conversations from the EAEA podcast Beyond Learning, and on the results of the EAEA Annual Conference on Adult Learning and Green Transition. The paper explores learners' motivation to engage in green transition and the values that they see at its core. It closes with a set of recommendations.

RECOMMENDATIONS ON HOW ALE CAN FOSTER GREEN TRANSITION

- **Strategies for ALE and the green transition take a long time to build.** They need to include the communities, the providers, the learners, the educators, trade unions, and decision makers at different levels to have robust foundations.
- **Organisations that aim to address green transition need to accept that they will need to constantly re-imagine themselves.** A forward-looking perspective should include an analysis of not only the broader policy agendas, but also the local context in which their learners are living in.
- **Learning needs to be strongly connected with the reality and lived experience of the learner and their immediate community, and foster a sense of belonging.** When possible, adult learning providers should reach out to the communities that are not included in learning to make sure that their voices are heard.
- **Adult learning providers and educators should address and encourage sustainability in all its dimensions.** It is a spectrum that is not just reduced to environmental sustainability, but also social sustainability, and the importance of keeping meaningful relationships.
- **Practise what you preach.** A whole institution approach to sustainability should be encouraged when possible.

Increasing EAEA's impact and visibility

2023 was a very strong year for EAEA: as a unique association at the European level giving a voice to non-formal adult learning and education, EAEA was a prime partner for events and consultations around the European Year of Skills. EAEA actively worked with a wide range of partners and stakeholders at the European, international, and national levels to build bridges across countries and sectors, bringing practice together with policy and research. Among other things, EAEA organised a launch event for the European Year together with the European Training Foundation and the Lifelong Learning Platform, which also brought the skills agendas of non-EU Eastern European countries into focus. Our work on the European Year gave us strong visibility and we are proud that non-formal ALE was recognised in the European Year thanks to our intensive awareness-raising work.

To strengthen EAEA's work on skills for life, EAEA expanded cooperation with many partners: EAEA joined the European Alliance for a Just Transition, concluded a Memorandum of Understanding with the European Association of Institutes for Vocational Training (EVBB) as well as the European Society for Research on the Education of Adults (ESREA), and also worked with the Bruegel Think Tank on a campaign on Skills.

EAEA also led several policy developments: EAEA's annual conference on Adult Learning and the Green Transition was an official partner of the EU Green Week, contributing to the themes and objectives of Erasmus+. Through our annual theme, we were also involved in European Parliament reports on Green Transition and Just Transition, which emphasised ALE, life skills, and transversal skills thanks to our input. EAEA's participation in the Citizens Panels of the European Commission was also a great success. Through written feedback, but also our participation in the panels themselves as external experts, we were able to participate in the idea harvesting process. The Commission's Proposal for a Council Recommendation 'Europe on the Move' attests to our impact, as well as to the great interest of Europe's adult citizens in participating in learning mobility.

EAEA not only responded to new policy processes but was also an agenda-setter: we introduced an initiative on Paid Transnational Education Leave, which was first discussed as a petition by the European Parliament and later also in other EU institutions. In recent EU documents, we see a development in this direction and are convinced that the adoption of a recommendation or similar will have a very positive impact on the participation in ALE of all adult citizens.

EAEA created a task force, composed of EAEA members, Board members, and secretariat, for the 2024 European elections, which prepared the work on a new EAEA Manifesto for Adult Learning (to be published in 2024) and discussed strategies for successful campaigns to raise awareness for ALE in meetings of a new election advocacy lab. This activity will continue in 2024 until the elections.

Thanks to the engagement of EAEA's members, EAEA was also able to have an impact at the national and regional levels: EAEA's membership of

the EC working groups on ALE and Equality and Values helped us contribute actively to national processes in the areas of Individual Learning Accounts and citizenship education. Furthermore, EAEA was invited by national ministries to provide informal and sometimes formal input to national implementation processes of European initiatives, such as Upskilling Pathways. We provided our members with templates for statements on ALE funding, especially Erasmus+ and ESF+, and were able to support them in drawing attention to their concerns at the national and regional levels. More impact of EAEA's work at the national and regional levels are collected in [the EAEA country reports 2023](#).

EAEA's policy work was particularly taken up by members in Sweden, Finland, the Netherlands, and Belgium, where there have been important political changes with a potential negative impact on participation in ALE. Our work empowered them to speak to their national and regional policymakers and raise awareness of the importance of the sector. Our collaboration with the UNESCO Institute for Lifelong Learning around the follow-up and monitoring of the Marrakech Framework for Action in Europe also allowed us to reach out to ministries and strengthen cooperation at this level.

Brussels-based events with a focus on policy and strategy, such as the roundtable on green transition, the EAEA 70th anniversary reception and the joint event on Civil Society for Lifelong Skills Development of EAEA, ETF and LLLP, brought together on average 30 participants. Several webinars for members were organised throughout 2023, ranging from topics such as the European Year of Skills, the EU elections, to the Erasmus+ learner mobility, which brought together on average 15 participants.

According to EAEA's member survey conducted in 2024, the members consider EAEA's advocacy and policy work very impactful. When evaluating EAEA's impact on different policy levels, 100% of respondents say the impact on the European level is "strong" or "very strong". This is followed by the impact on the organisation's level (78% "strong or "very strong"), which has been increasing over the past few years.

Strengthening networks through capacity-building

EAEA worked intensively on new strategies for capacity-building and stakeholder engagement, to work more closely with our members and their members at the grassroots level and to reach out to citizens.

EAEA developed a new format for the EAEA Younger Staff Training, a popular learning opportunity for young ALE professionals, to reach more participants. Instead of a multi-day face-to-face training course in Brussels, EAEA launched an online training course with 4 course modules that encourage interactivity and collaboration with other participants. The course, based on Moodle, is available on EAEA's website <https://learning.eaea.org> and can be started at any time, i.e. even beyond 2023. The course modules include the topics of why ALE is needed, which ALE practices there are in Europe, learning methods and approaches, and policy and advocacy.

In 2023, EAEA also introduced a completely new format, a podcast entitled "Beyond Learning", which can be accessed via Apple Podcast, Spotify, and other streaming services. The podcast, which explores the

many sides of non-formal ALE, is hugely popular with adult educators and adult learners who can relate to the stories and interviews from their personal experience. It also serves to raise awareness among policymakers of the realities and the diversity of ALE in Europe. In 2023, the podcast's theme was the green transition, and a total of 7 episodes introduced listeners to the worlds of upcycling, creating, sustainable lifestyles, and other topics. Additionally, an online training course on <https://learning.eaea.org> accompanied the episodes of the podcast. In Hungary, EAEA's podcast is currently in the top 40 of educational podcasts, and it is also climbing the ranking in other countries.

EAEA also hosted several training activities and study visits for its members from Finland, Norway, Ireland, and Switzerland, as well as EAEA research partner ESREA, with tailor-made programmes. To improve co-operation with the academic level, EAEA also welcomed ESREA's coordinator Marcella Milana for a few weeks in Brussels and introduced her to EU policy work in the field of ALE. EAEA's many years of experience have shown that these study visits are particularly effective in terms of the sustainability of EAEA's activities.

Engaging stakeholders for cross-sectoral cooperation

EAEA fosters collaboration and knowledge exchange among adult learning and education (ALE) stakeholders throughout Europe. Through EU-funded projects, EAEA has facilitated regional cooperation and established national and regional umbrella organisations in areas where they were lacking. This has notably enhanced cooperation among Central European countries and bolstered associations in the Baltic States.

EAEA's Advocacy Academy is now expanding cooperation in the Balkans and Eastern Europe, using peer learning methods to advance joint learning processes and ALE strategies. Moreover, EAEA's partnerships with RREUSE and the European Alliance for a Just Transition, launched in 2023, establish new networks vital for transformative ALE. These collaborations inform EAEA's policy efforts, including sustainability papers, and reciprocally benefit from EAEA's insights on ALE's role in the green transition.

Furthermore, EAEA's Memorandum of Understanding with EVBB strengthens cooperation between non-formal ALE and vocational education and training (VET) at the European level. Finally, EAEA's involvement with the Belgian Bruegel Think Tank expands its stakeholder network, connecting with academia and other key think tanks.

Cooperating across sectors and areas of work

EAEA's various European civil society partners provided a multiplier effect within their networks. These include the Lifelong Learning Platform, Social Platform, SOLIDAR, EUCEN, ESREA, ESBN and CONCORD. EAEA's Head of Policy Raffaella Kihrer was elected General Secretary of the LLLP in September 2023. A multiplier effect at the global level was ensured through ongoing collaboration with EAEA's global body ICAE, EAEA's sister organisations AAACE (Northern America) and ASPBAE (Asian Pacific Area), and a partnership with the UNESCO Institute for Lifelong Learning.

International cooperation

At the international level, EAEA engaged and achieved impact in several important processes:

- **European follow-up of UNESCO's CONFITEA VII:** EAEA organised a European follow-up conference to CONFITEA VII on 9 October 2023 together with the UNESCO Institute for Lifelong Learning (UIL) and the Lifelong Learning Platform (LLLP); see more information in the dedicated section on events.
- **World Assembly of the International Council for Adult Education (ICAE):** EAEA participated in the World Assembly of ICAE in November 2023, sharing the European experience with ALE policy development and implementation and connecting to ALE organisations and professionals from around the globe. The new network has already had its first fruits: EAEA was invited to present the European implementation process of the MFA and its connection to the European Education Area at an online conference of the North-American organisation COLLO in 2024.
- **UNESCO CCNGO:** EAEA, represented by Christoph Jost from DVV International, was newly elected to the board of the UNESCO Collective Coordination Group ED 2030 (CCNGO) in 2023. EAEA is thus the

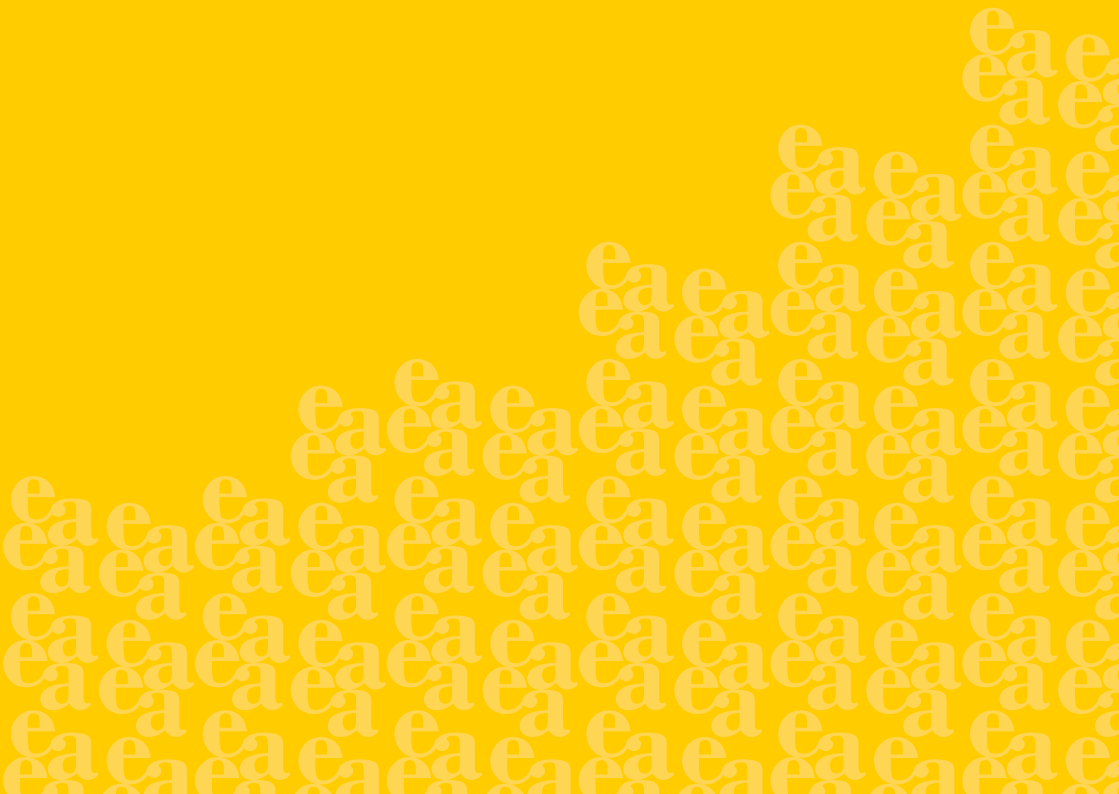
official representative of civil society in the field of education and lifelong learning for Europe and in this role works closely with representatives from other regions of the world. The Collective Consultation of NGOs on Education For All (CCNGO/EFA) is UNESCO's main mechanism for dialogue, reflection and partnerships with NGOs within the EFA movement. It is included in UNESCO's regular programme.

- **DEAR multistakeholder group of DG INTPA, European Commission:** EAEA's Deputy Secretary General Raffaella Kihrer represents European civil society in lifelong learning on behalf of the Lifelong Learning Platform in the DEAR (development education and awareness raising) multistakeholder group of DG INTPA of the European Commission. The Multistakeholder Group dealt with the European Year of Skills 2023 and the prioritisation of the future DEAR programme. EAEA brought the lifelong learning dimension of DEAR to the foreground and encouraged closer cooperation with other DGs of the European Commission.

Grundtvig Award 2023

The EAEA Grundtvig Award 2023 centred on Adult Learning and the Green Transition, recognising the vital role of adult learning and education in addressing the challenges posed by climate change and environmental degradation. The winners were selected in two categories: national initiatives and transnational initiatives. EAEA awarded the two organisations on 6 June 2023 in Zagreb, Croatia.

WINNER IN THE NATIONAL CATEGORY

Women's economic empowerment in Shirak and Gegharkunik Marzes

The winning project is run by Green Lane Agricultural Assistance NGO in Armenia. The NGO has supported farmers in the transition to sustainable agriculture since 2004. The women participating in the project come from disadvantaged backgrounds, and the project has allowed them to gain knowledge and experience in sustainable agriculture and improve their economic situation, as well as serve as an example to the residents in their communities.

Building green skills for circular economy

Run by Fenan Consulting, the Netherlands, the project Building green skills for circular economy involves people from disadvantaged social groups, such as migrants, refugees, and senior citizens, to share their circular skills and sustainable lifestyles with adult learners. The Erasmus+ funded project has increased social recognition by bringing in marginalised groups as educators and inspirational examples in the online course. Non-formal learning club “WE” from Lithuania is a partner in the project.

Annual Conference on Adult Learning and the Green Transition

EAEA held its annual conference on Adult Learning and Green Transition on 7 June in Zagreb, Croatia. The event was attended by 120 participants from 26 countries. Our keynote speaker Arjen Wals, Professor of Transformative Learning for Socio-Ecological Sustainability and UNESCO Chair Social Learning for Sustainable Development gave a speech titled “A just green transition in times of crisis: how can adult learning help us build a more sustainable world?”

The conference explored two strands. The first strand, “Learning in communities” focused on community dialogue and political engagement through several thematic sessions, which included a learner roundtable, two parallel workshops, and an interactive world cafe. The two workshops focused on Green transition and democratic processes: getting everyone on board and Adult learning as a space for political engagement. In the second strand, “Strategies for a just green transition”, participants explored the more policy and strategy-related aspects of adult learning and the green transition during a policy roundtable, two parallel workshops, and a world cafe session. The two workshops looked at Building green partnerships and Developing a green skills strategy. Full results are available on the [conference website](#).

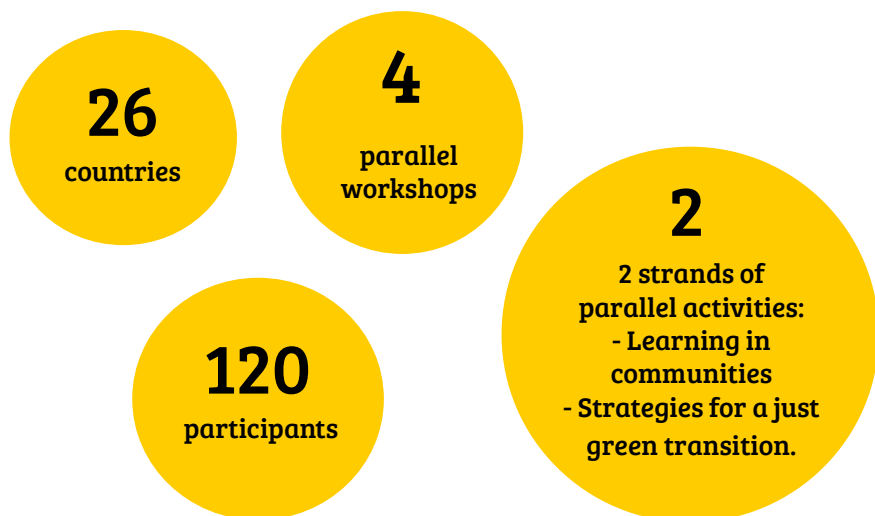

The outcomes of the conference were used to develop an EAEA background paper, featuring case studies and recommendations, with a focus on learner voice.

EAEA Younger Staff Training

In 2023, the annual EAEA Younger Staff Training took place online under the title Introduction to Adult Learning in Europe, hosted on EAEA e-learning platform learning.eaea.org. The course includes four modules:

1. What is adult education, and why do we need it?
2. Adult learning practice in Europe: case studies from selected countries
3. Adult learning methods and approaches
4. Adult learning policy and advocacy.

By the end of 2023, around 50 participants had enrolled in the course.

Advocacy Academy in Sarajevo, Bosnia and Herzegovina

The Advocacy Academy was co-organised by DWV International, the International Council for Adult Education, and EAEA to assist adult learning organisations from six countries in creating their advocacy plans. Following the first session of the training in Turkey in 2022 (jointly led by EAEA and ICAE), EAEA's Raffaella Kihrer and Davide Muraro, together with ICAE's Secretary-General Katarina Popovic, designed and implemented a second workshop in Sarajevo in May/June 2024 for 30 participants from Armenia, Bosnia and Herzegovina, Georgia, Kosovo, Moldova, and Ukraine. The country representatives presented their draft advocacy plans and exchanged feedback, suggestions and best practices, benefiting from inputs from both trainers and fellow participants.

ETF-LLLP-EAEA joint conference “Civil society for lifelong skills development in Europe and partner countries”

The European Training Foundation (ETF), the Lifelong Learning Platform (LLLP), and EAEA) joined forces in promoting policy dialogue and partnerships between governments and civil society organisations that are active in the sector, both in ETF Partner Countries and EU Member States, as a means towards access to good quality lifelong learning for all. The conference, held on 23 May 2023. included a large number of high-level speakers from the European Commission, the European Parliament, the European Economic and Social Committee, and the OECD. 60 participants attended the event.

European follow-up of CONFINTEA VII with UNESCO Institute for Lifelong Learning (UIL) and LLLP

Together with the UNESCO Institute for Lifelong Learning (UIL) and the Lifelong Learning Platform (LLLP), EAEA organised a European follow-up conference to CONFINTEA VII on 9 October 2023. The online event was attended by a large number of European ministries responsible for ALE, and speakers included representatives from the European Commission, ETF and EESC.

CONFINTEA VII took place in Marrakech, Morocco, in 2022 and EAEA had played a decisive role in the final version of the Marrakech Framework for Action (MFA). EAEA's close collaboration with UIL on the MFA implementation process will, therefore, continue in the coming years, and, as a result of EAEA's engagement in the process, EAEA has also been invited to speak at events organised by North-American and Asian ALE organisations to share the European experience.

EAEA Grundtvig Award publication

Each year, EAEA awards excellent and innovative projects that follow our annual topic. The 2023 Grundtvig Award publication presents 17 adult learning initiatives that strived to build capacity for greening adult learning and education. The publication, released digitally in November 2023, was widely disseminated to relevant stakeholders and policymakers on European, national and regional levels.



Adult education in European countries from a civil society perspective

The annual EAEA country reports provide civil society insight into adult education developments across Europe. In 2023, a new survey format was launched to further increase the quality and representativeness of the data, resulting in a higher number of countries included. For the first time, the country reports included several learners' stories. EAEA asked its members about, financing, participation of learners, and the involvement of civil society organisations in decision-making processes, awareness, and engagement in international and EU initiatives, among other topics. The reports are published digitally on the country report website.



International Council for Adult Education: 50 years in adult learning and education

In 2023, EAEA's longtime partner the International Council for Adult Education celebrated its 50th anniversary. EAEA supported ICAE by leading the work on a publication that brought together ICAE's main achievements. In addition to coordinating the contributions with the support of the Editorial Board, EAEA produced the layout for the publication and interviewed ICAE members for one of the contributions. The publication was launched at ICAE's World Assembly in Bali, Indonesia in December 2023.

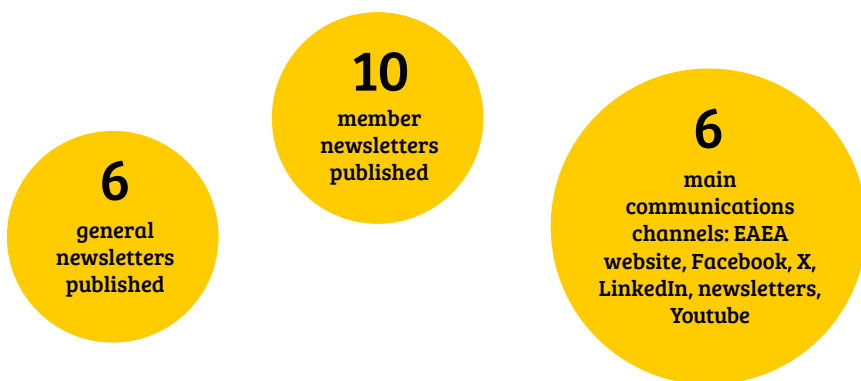

Communication channels

EAEA successfully implemented its communications and information strategy in 2023, reaching thousands of stakeholders, educators, and adult learners in Europe and beyond. To ensure a good foundation for EAEA's communications work in the coming years, EAEA updated the new communications strategy for the next 2-year period. EAEA also launched a new Beyond Learning podcast, which was actively promoted through EAEA's channels and reached a good number of listeners.

EAEA worked on the continuous professionalisation of the communications and the involvement of EAEA's members in communication. Among other things, EAEA planned a communication campaign for the upcoming European elections with the members. Communication was reinforced through a new staff member who supports communications and capacity-building.

The EAEA website and social media channels remained the main reference point for information on new adult education policy developments. Number of users on eaea.org website dropped slightly (from 44 000 to 38 000), which is potentially caused by the changes in the analytics tools used. In July 2023 Google enforced change from Google Analytics 3 to GA4, and in November 2023 EAEA replaced Google Analytics with more GDPR-compliant Matomo. EAEA Facebook account continued growing (more than 9000 users by the end of the year), and X/Twitter account (5800 followers) gained a high level of engagement (nearly 5% rate), which means our followers find our content interesting and useful. EAEA's LinkedIn profile attained more than 3100 followers, with a growth of 48 percent. LinkedIn allowed EAEA to reach a professional audience that is otherwise rather difficult for EAEA to reach.

EAEA disseminates information to its members through various channels. EAEA's general newsletter was published 6 times and the member newsletter 10 times in 2023. In addition to the newsletters, the EAEA Secretary General e-mailed the members about important policy developments. For example, in 2023, "News From Brussels" channel was used to report on EAEA's successes with the Commission's proposal on Europe on the Move. EAEA also adopted a more direct approach to specific interest groups through invitations to events, social media outreach, and meetings face-to-face and online.

EAEA continued to be an active member of the advisory board of the Electronic Platform for Adult Learning in Europe (EPALE) in 2023. EAEA also remains on the Editorial Board of ELM Magazine. These collaborations have helped EAEA to expand its reach and impact.

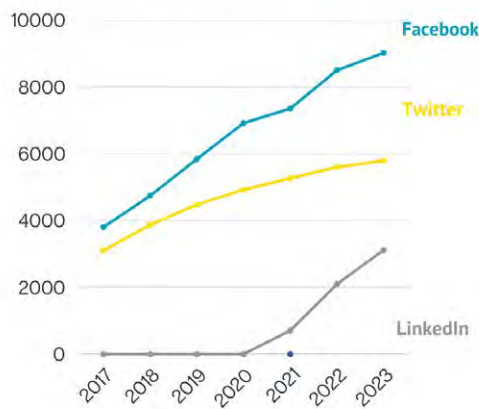

Satisfaction with EAEA's communication work

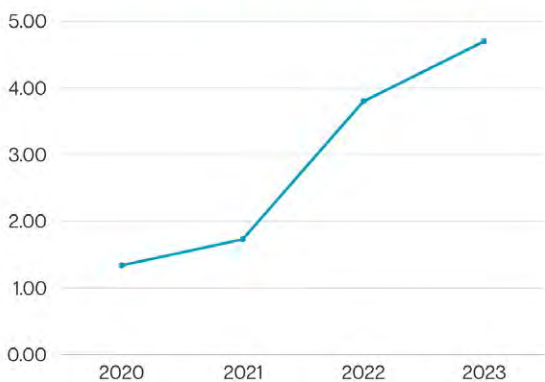
100 % who replied to EAEA member survey felt either "very satisfied" or "satisfied". Members were particularly appreciative of Policy news, news

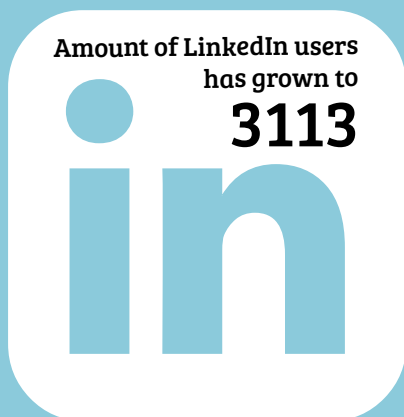

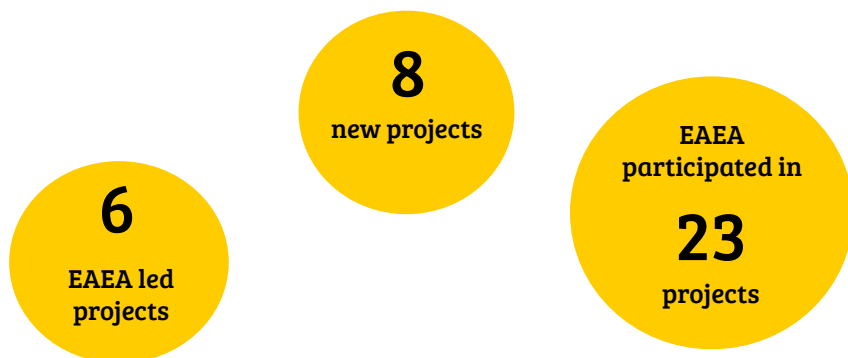

EAEA 's project work in 2023 at a glance:



EAEA's projects focus on, on one hand, on advocacy and policy and, on the other hand, on design, implementation and exchange of practices in adult education and lifelong learning. EAEA participates mainly in Erasmus+ projects but also other funding programmes, such as Horizon Europe and CERV. With EAEA steadily broadening its engagement in project work, current projects are not only aiming at a concrete, practical level but also in creating impact on a more systemic and policy support level.

The projects cover a wide range of topics, such as partnerships and cooperation in ALE systems (Partner-Up, RegALE), supporting sustainability and green competences through ALE (SMALEI, TALE, Engage4BIO and LEVERS), improving adult participation in education and social inclusion (ENHANCE, MOVE-UP, JUST4ALL, ALL-IN), emerging technologies application in ALE (e.g., AI4AL) and improving learning spaces (SAFE). In 2023, EAEA was involved in additional projects targeting older learners (e.g., AgeingWell, E-enAGED, COPE and SAA).

Included target groups are low-skilled adults, older learners, as well as ALE organisations and educators, with some projects aiming also at the systemic and strategic levels involving public authorities.

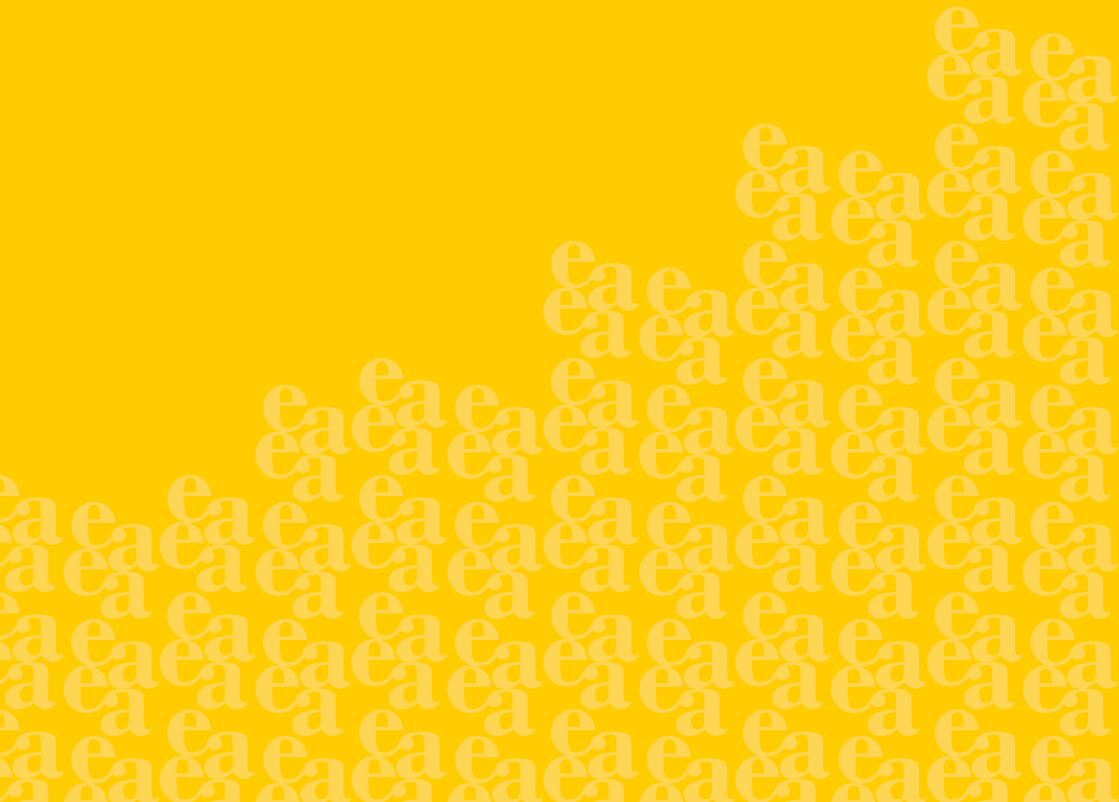

In 2023, the EAEA maintained a close partnership with its members. Members were invited to participate in online discussions and contribute to consultations and EAEA working groups. Two working groups focussed on members' contributions: the working group on financing ALE and the working group on quality in ALE. In addition, EAEA continued the activities of the "Europe is more than the EU" working group and brought members together to discuss relevant topics.

Member satisfaction

According to the results of the member survey conducted in 2024, the general satisfaction with EAEA work and services has stayed high, 100% of members who responded to the survey describe themselves as "satisfied" or "very satisfied". The highest satisfaction rates were recorded for advocacy work on the European level for non-formal adult education and lifelong learning, our cooperation with EU institutions and national and international NGOs, and dissemination of ALE project information.

When evaluating EAEA's impact on different policy levels, 100% of respondents say the impact on the European level is "strong" or "very strong" (similar to last year 96%). This is followed by the impact on the organisation's level (78% "strong" or "very strong"), which has been increasing over the past few years.

The Executive Board and its preparatory body, the Bureau - composed of President, Vice-Presidents and Secretary General - are responsible for the overall direction and policy development of the association. The Board works primarily on a policy and strategic level, leaving the running of the association to the Secretary General. Nevertheless, members of the Executive Board regularly advise the secretariat on different matters, from practical to operational to general. The role division is clearly defined in the constitution of the association.

Finances

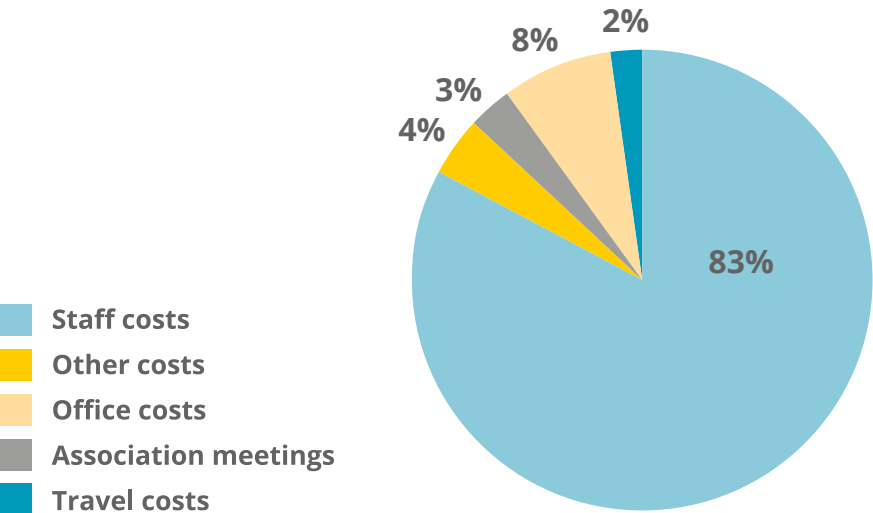
In 2023, EAEA successfully applied for a three-year framework contract with the European Commission's Education, Audiovisual and Culture Executive Agency (EACEA), and a one-year operating grant contract. EAEA also renewed its service contract with EPALE for the provision of content and expertise.

In 2023, EAEA won a centrally managed ESF+ project ("EaSI" - Employment and Social Innovation), an Erasmus+ Forward-Looking project on Individual Learning Accounts, as well as an Erasmus+ ENGO (centrally managed Erasmus+ project for European NGOs), and continued to successfully participate in other Erasmus+ and Horizon Europe projects. Project funding remained a key source of funding for EAEA's activities in 2023.

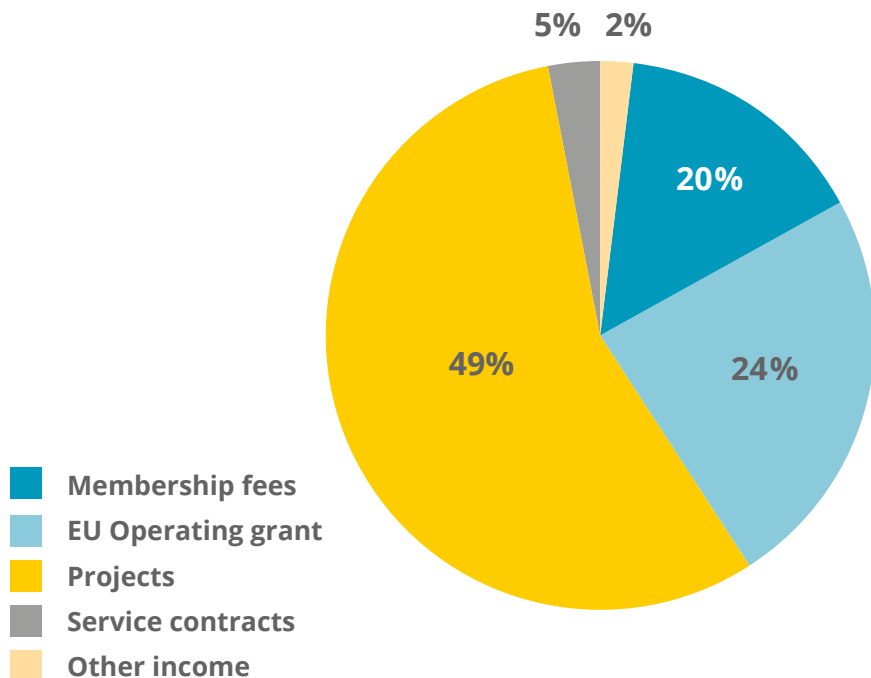
To maintain the independence of EAEA's positions, membership fees continued to play an important role in 2023.

The distribution of expenditure remained similar to previous years. Staff costs remained the largest item, as is usually the case with non-profit organisations in advocacy.

Marina Sakač Hadžić, who previously held a Belgian entry-level contract (convention d'immersion professionnelle) at EAEA, was recruited for the position. 50 per cent of the full-time position is financed by the Maribel Funds, and 50 per cent from other EAEA funds.
